B. Response to sickness		
1. Prayer of faith		
a. Matthew 8:2-3 - When the leper asked Jesus to heal him if He, i.e. Jesus, wa		
willing – multiple choice:		
(1) Jesus soundly rebuked him for his lack of faith		
(2) Jesus mildly rebuked him for his lack of faith		
(3) Jesus stated that to ask in that manner was really to doubt God's		
promises.

Question: Jesus' response to the father of the demon-possessed boy, shows that Jesus was addressing – multiple choice:

- (1) The father's doubts concerned whether it was Jesus' will to heal.

- (4) that faith was not an issue
- 2. James 5:14-16 Calling for the elders of the church
 - a. The words translated "restore" in the NAS and "make well" in the NIV are correctly translated "save" in the NKJV and KJV. This speaks of salvation from multiple choice:
 - (1) the penalty of sin, i.e. the second death which is the lake of fire.
 - (2) the power of sin in the Christian's daily life
 - (3) the presence of sin at Christ's return
 - (4) physical death as a result of the illness
 - b. The word "save" in the previous question implies that multiple choice:
 - (1) the illness is definitely caused by sin
 - (2) the illness is of a spiritual nature rather than a physical nature
 - (3) the illness is serious and at least potentially life-threatening
 - (4) the illness is not serious
 - c. In order for the elders to do this multiple choice:
 - (1) the sick person needs to take responsibility to call for or have someone call for the elders of the church.
 - (2) the elders need to take the initiative and go the sick person.

C. Is physical healing in the atonement

Note: Some believe that physical healing may be claimed by faith in the same way as salvation based on Isaiah 53:4-5

- 1. Matthew 8:16-17 quotes Isaiah 53:4. According to Matthew 8:16-17 multiple choice:

D. Some questions
1. 3 John 1:2 – This is – multiple choice:
a. a promise for good health
b. a provision for good health
c. a prayer for good health
d. nothing to do with health
2. 1 Corinthians 12:9 – Which spiritual gift in this verse deals with sickness?
Note: Having the gift of healing does not guarantee that everyone the person ministers to will always be healed. The gift of teaching does not mean that everyone who hears will learn. The gift of evangelism does not mean that everyone approached will be won to Christ. Having the gift of leadership does not mean that everyone will follow or obey.
3. Acts 5:15-16; 19:11-12 – During the very early church age, healing was – multiple choice:
a. very widespread and almost unlimited
b. very limited
c. not present since Jesus had ascended and gone back to heaven
4. 1 Timothy 5:23; 2 Timothy 4:20 - A few decades after this healing was – multiple choice:
a. very widespread and almost unlimited
b. obviously limited
c. totally unlimited

Note: God healing or not healing a person in the above two questions obviously has to do with His sovereignty and not with the giftedness or yieldedness of the healer. No one could have been found who was more gifted or yielded than the Apostle Paul.

- 5. Isn't it wrong to claim that God works differently from one period of time to another period of time? After all Hebrews 13:8 states that "Jesus Christ is the same yesterday, today and forever."
 - a. Read Genesis chapter 5. People during the time before the flood lived multiple choice:
 - (1) past 700, 800 and 900 years in many cases
 - (2) about 30-35 years
 - (3) 70 to 80 years
 - b. Psalm 90:9-10 Many centuries later during the time of Moses, the life span of people was multiple choice:

Note: Looking at question 5 and question 4, it is obvious that the people involved were not any more or less godly or believing from one period of time to another. However, it is very obvious that while Christ does not change according to Hebrews 13:8, that what He sovereignly gives or withholds does change.

Note: Both prayer and medicine are given by God. So it is not a case of "either...or" but "both...and". We must remember that it is God who heals not some but all of our diseases (Psalm 103:3).

- 7. John 14:12 Christ stated that the one who places their faith in Him multiple choice:
 - a. will do the same works as Christ did.
 - b. will do greater works than Christ did
 - c. will not do the same works nor greater works than Christ did
 - d. both a and b

Note: The greater works are believed by many to be the bringing of people to eternal life by sharing the gospel. The question is when will we do the same works as Christ. Jesus showed John the Baptist in Matthew 11:2-5 that He was the promised king who would do the healings of Isaiah 35:5-6. The early Christians had tasted or experienced the powers (literally "miracles") of the age to come(Hebrews 6:5). These miracles were done by Christ and the Apostles (Hebrews 2:3-4). Since we will rule with Christ on the earth (Revelation 5:10), there is reason to believe that we will do the same works at that time if we do not do them in this life.
